Audit Findings

Audit Narrative

The Dove Vocational Academy (Dove Academy), located in Graceville, Florida, is operated by Twin Oaks Juvenile Development, Inc. through a contract with the Florida Department of Juvenile Justice (FDJJ). The facility's first PREA audit was conducted in May 2015. The current audit was attained and assigned to the Auditor by Correctional Management and Communications Group, LLC of Minneola, Florida.

In preparation for the on-site audit, a conference call was conducted with the Florida Department of Juvenile Justice (FDJJ) Statewide PREA Coordinator, the facility's Program Director, who also serves as the PREA Compliance Manager, the agency's Chief Operating Officer (COO)/PREA Coordinator, an administrative staff from the corporate office, and this Auditor to discuss the audit process and data gathering. During the call, introductions were made and the audit process and requested documentation were reviewed. The notifications of the on-site audit were posted six weeks prior to the audit, providing auditor contact information. The posting of the notices was verified by photographs received electronically from the Program Director. The photographs indicated notices were posted in various locations throughout the facility including the housing areas, classrooms, and administrative areas.

The Pre-Audit Questionnaire and the supporting documentation were uploaded to a USB flash drive, which was received approximately three weeks prior to the on-site audit. During the review of the information on the flash drive, communication was maintained with the facility and agency staff and additional information was provided or clarified as requested.

An entrance meeting was held with the Program Director, COO/PREA Coordinator, identified staff from the facility, and an administrative staff from the corporate office. Following the meeting, the Auditor conducted a tour of the facility. During the tour, youth were observed to be under constant supervision of the staff while involved in school and other activities. The facility was clean and well maintained. Staff announced themselves prior to entering the housing area of the opposite gender. Observation of community bathrooms revealed shower stall openings have shower curtains to allow residents privacy when taking showers; also, there were doors to allow for privacy in the toilets. Observations were also made by the Auditor that PREA signage was not displayed in

areas frequented by the residents; therefore, the Auditor recommended this facility post additional PREA signage and ensure it has bold print and is child friendly. Corrective actions were taken to rectify this issue. Photos of the additional signage were sent to the Auditor to verify the actions taken.

An early morning arrival at the facility allowed this Auditor to interview overnight shift and to observe overnight and early morning operations. Twelve random direct care staff from the two shifts and nine specialized staff were interviewed. Overall, the interviews revealed staff are knowledgeable of PREA standards and were able to articulate their responsibilities. Ten residents were also interviewed. The interviews revealed the residents were informed of their right to be free from sexual abuse and sexual harassment and how to report sexual abuse and sexual harassment. The interview selections were randomly made from rosters provided by the facility. There were no targeted residents to be interviewed at this facility during this auditing cycle. The training records of staff interviewed, and the files of residents interviewed were reviewed along with policies and other secondary documentation.

The Auditor reviewed staff, contractor and volunteer training records to ensure all required training had been completed. The Auditor also reviewed staff personnel files to determine if there were any completed investigations and disciplinary actions taken regarding PREA related allegations.

The victims' advocacy service, Gulf Coast Children's Advocacy Center, was contacted to determine the scope of services provided. A representative responded to the call and indicated there were no calls received from the Dove Academy residents over the past 12 months.

Additional information for the audit process was provided upon request and in a timely manner while on-site. A close-out meeting was held at the conclusion of the site visit and an opportunity for questions and a review of the on-site audit process were provided to the facility and agency staff in attendance.

With the necessary corrective action addressed, the facility was found to be in compliance with all applicable standards as indicated below and detailed throughout this report.

Facility Characteristics

The Dove Academy is a non-secure, moderate risk facility that serves female juvenile

offenders between the ages of 15-18. The average length of stay is approximately 3-9 months. The facility's rated capacity is 38. Forty-two residents have been admitted to the Dove Academy in the past 12 months. The facility is equipped with a video surveillance system which includes 63 cameras.

The physical plant consists of an administration building which houses administrative offices, reception/lobby area, control room, conference room, and the dining hall. Other buildings include three dorm buildings, one educational building, a medical building, and a greenhouse. Each dorm building contains a day room area and offices. A full bathroom is in each dormitory and provides a reasonable amount of privacy for the residents. The facility provides supervision of residents in a safe, secure and humane environment. A pavilion sits in the center of the grounds with the buildings surrounding it. Two basketball goals are posted under the pavilion. The outside grounds also contain a garden that is maintained by the residents as a part of their Boys and Girls Club activities under the supervision of staff. There is space where youth can participate in various sports and activities. Visitation is conducted on Sundays.

The Dove Academy employs one Program Director, one Assistant Program Director/Training staff, one Human Resource/Purchasing staff, Medical staff, Educational staff, Mental Health/Substance Abuse staff, Maintenance staff, Boys & Girls Club staff, three Case Managers, one Transitional Specialist, four Shift Supervisors, twenty-eight Direct Care staff, one Transportation Crew Leader, one Recreational Specialist, and two Food Service staff. Medical services are provided by on-site medical staff.

Dove Academy meets the requirements of this standard based upon the following evidence:

The facility adheres to the Twin Oaks Juvenile Development, Inc. Prison Rape Elimination Act (PREA) Policy. It affords guidelines for implementing the agency's approach to complying with the requirements of the PREA standards. The Policy provides for a zero-tolerance approach regarding all forms of sexual abuse and sexual harassment. It contains definitions of the prohibited behaviors and sanctions for those who participate in such behaviors. The agency's PREA Policy and the facility's operating procedures are aligned with the Florida Department of Juvenile Justice PREA Policy (FDJJ 1919).

Agency Policies address "Preventing" sexual abuse and sexual harassment through the designation of a PREA Coordinator and PREA Compliance Manager; Criminal History Background Checks and Child Abuse Registry Checks (Staff, Contractors, and Volunteers, as applicable); Training (Staff, Volunteers, and Contractors); Staffing; Intake Screening; Classification; Resident Education; Posting of Signage (PREA Posters, etc.); and Contract Monitoring. The Policies address "Detecting" sexual abuse and sexual harassment through Training (Staff, Volunteers, and Contractors), and Intake Screening. The Policies address "Responding" to allegations of sexual abuse and sexual harassment through Reporting; Investigations; Victim Services; Medical and Mental Health Services; Disciplinary Sanctions for Staff (including notification of licensing agencies); Incident Review Teams; and Data Collections and Analysis.

An interview with the PREA Coordinator revealed he has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards in all of the agency's facilities. The facility's Program Director serves as the PREA Compliance Manager. An interview with the PREA Compliance Manager revealed she has sufficient time to oversee the facility's PREA compliance efforts and to perform her other duties.

Based on staff interviews and a review of practices, it was noted staff closely monitor for resident-on-resident sexual misconduct in accordance with the PREA standards.

Dove Academy meets the requirements of this standard based upon the following evidence:

The facility's PREA Policy and practices provide for the implementation of a staffing plan with adequate staffing levels to protect residents against sexual abuse and provides that the staffing ratios are per the current program contract. According to the staffing plan and staff interviews the ratios within the facility are 1:6 during the awake hours and 1:8 during the sleeping hours.

The assessment of the staffing plan determines whether adjustments are needed in accordance with the standard. The staffing plan details the methodology that ensures adherence to the staffing ratios. Documentation of the annual review of the staffing plan dated June 12, 2017 was reviewed and found in compliance with all elements contained in (d)-1 of this standard. The state-wide PREA Coordinator and the Program Director reviewed the staffing plan to determine if adjustments are needed; no adjustments were made during the review.

Unannounced rounds of the facility for the maintenance of a safe environment are conducted and documented by members of the management team. Policy and practice provide staff members are prohibited from alerting other staff regarding unannounced rounds occurring. An Interview with a higher- level staff member confirmed the practice.

Dove Academy FOP PREA prohibit cross-gender strip searches, or pat down searches of residents, except in exigent circumstances and there have been no such searches conducted by direct care staff in the past 12 months as verified by random staff and random resident interviews.

The facility's PREA Policy states body cavity searches require the Program Director's authorization and must be conducted by licensed medical personnel in a medical establishment. There were no body cavity searches of residents in the past 12 months

The PREA Policy states the facility must be configured to allow residents to shower, perform bodily functions and change clothing without staff of the opposite sex viewing their bodies. Staff and resident interviews confirm there is no cross-gender viewing. Observation of the bathrooms revealed all shower stalls have shower curtains to allow privacy while taking showers.

FDJJ Policy 1919 PREA and the facility's PREA Policy require opposite sex staff, volunteers and contractors entering housing units to announce themselves. Resident interviews verified this is done on consistent basis.

FDJJ Policy 1919 and the facility's PREA Policy prohibit the search of a transgender or intersex resident solely for the purpose of determining the resident's genital status and staff interviews verified compliance.

One hundred percent of direct care staff have received training on cross-gender pat down searches and searches of transgender and intersex residents. The training was verified during interviews of random staff. Training curriculum and training logs were reviewed and confirmed compliance.

The collective Policies and interview with the Human Resource staff member revealed information regarding the hiring process, completion of background checks, and the grounds for termination. The Policies are aligned with the requirements of the standard and provide that background checks are conducted initially and every five years. A review of a sample of personnel files confirmed compliance.

A pre-hire form requires applicants to provide information regarding previously related sexual misconduct allegations and convictions. The policies prohibit hiring or promoting anyone who may have contact with residents and prohibit enlisting the services of any contractor who may have contact with residents who engaged in previous sexual misconduct.

According to the Human Resource staff, the facility considers any incidents of sexual

abuse or sexual harassment in determining whether to hire a person, contract for services, or whether to promote an employee. Policies FDJJ 1800 and FDJJ 1919 and the interview with the Human Resource staff provide staff has a continuing duty to report misconduct and provide omissions of misconduct or providing false information will be grounds for termination.

The PREA Coordinator provided documentation that Florida State law does not allow FDJJ or other agencies to contact the abuse registry for the purpose of screening applicants.

A review of personnel files for a sample of staff hired in the past 12 months revealed all had criminal records checks and a sample review of personnel files of current staff employed for more than 5 years revealed all have had criminal background checks conducted every five years.

The facility's PREA Policy addresses this standard and states that staff is expected to cooperate in investigations conducted by the FDJJ Office of the Inspector General (OIG). Administrative investigations are conducted by OIG and criminal investigations are conducted by the Florida Department of Children and Families and local law enforcement. The PREA Policy states that upon the arrival of law enforcement investigators, a copy of the PREA Compliance Form will be provided to them which contain the PREA standards requirements regarding investigations.
