Audit Findings

Audit Narrative

The Juvenile Unit for Specialized Treatment (JUST)/Twin Oaks Academy II (TOA II), located in Sumatra, Florida is operated by Twin Oaks Juvenile Development, Inc. It is a residential non-secure facility that serves male juvenile offenders between the ages of 10 and 17. The average length of stay is approximately 4–12 months. The facility's rated capacity is 44. Forty-Seven residents have been admitted to the JUST/TOA in the past 12 months. The facility's first PREA audit was conducted in January 2015. The current audit was attained and assigned to the Auditor by Correctional Management and Communications Group, LLC of Minneola, Florida.

The current on-site audit was conducted January 8-9, 2018. In preparation for the on-site audit, a conference call was conducted with the Florida Department of Juvenile Justice (FDJJ) Statewide PREA Coordinator, the facility Program Director, and the facility Trainer who also serves as the PREA Compliance Manager. During the conference call, introductions were made and the audit process and requested documentation were reviewed.

The notifications of the on-site audit were posted in various parts of the facility at least six weeks prior to the site visit. Photographs were taken of the various sites where the notices had been posted and the photographs were electronically sent to the Auditor, noting their locations. The Pre-Audit Questionnaire and the supporting documentation were uploaded to a flash drive, which was received approximately three weeks prior to the on-site audit. During the review of the information on the flash drive, communication was maintained with the facility and agency staff and additional information was provided or clarified as requested. The Chief Operating Officer (COO) for Twin Oaks Juvenile Development, Inc. also serves as the agency's PREA Coordinator.

An entrance meeting was held with the Program Director, Facility Trainer, COO/PREA Coordinator, and an administrative staff from the corporate office. Following the entrance meeting, a comprehensive tour of the facility was provided by the Program Director, accompanied by the staff present during the entrance meeting. During the tour, direct-care staff was observed to be supervising and interacting with the residents.

Ten randomly selected residents and 12 direct care staff members were interviewed. Eight specialized interviews were also conducted during the on-site audit process. During the tour, observations were made by the Auditor that this facility should post additional PREA signage

that has bold print and is child friendly.

Additional information for the audit process was provided upon request and in a timely manner while on-site. A close-out meeting was held after the conclusion of the site tour and a review of the onsite audit process was provided to the facility and agency staff that were in attendance.

The facility was found to be in compliance with all applicable standards as indicated below and detailed throughout this report.

Facility Characteristics

The program is located on 72 acres, in a wilderness setting, surrounded by the Apalachicola National Forest. The main building contains the entrance lobby and administrative and other offices. There are five dormitories, including one honor dormitory; chow hall; medical station; education building; vocational building; and a building that houses the Boys and Girls Club. The meals for the residents are prepared in the large kitchen at another agency program facility located on adjacent property and transported and served in the JUST chow hall.

The facility provides supervision of youth in a safe, secure and humane environment. Each dormitory has a day room and full bathrooms that provide a reasonable amount of privacy for the residents. The outside grounds contain a recreation area in ample size to accommodate various recreation and other activities. The grounds also contain a large garden that is tended to by the residents under the supervision of staff.

During the onsite audit, the current population was 37 residents. The agency reported 47 residents had been admitted to the facility in the past 12 months and 54 staff employed at the facility during the past 12 months. The agency reported three contracts with contractors who might have contact with residents and three volunteers and contractors currently authorized to enter the facility.

The facility adheres to the Twin Oaks Juvenile Development, Inc. Prison Rape Elimination Act (PREA) Policy. It affords guidelines for implementing the agency's approach to complying with the requirements of the PREA standards. The agency mandates a zero-tolerance policy towards all forms of sexual abuse and sexual harassment and outlines the agency's strategies on preventing, detecting and responding to such conduct.

JUST/TOA II meets the requirements of this standard based upon the following evidence:

The facility's PREA Policy and practices provide for the implementation of a staffing plan with adequate staffing levels to protect residents against sexual abuse and provides that the staffing ratios are per the current program contract. According to the staffing plan and staff

interviews the ratios within the facility are 1:8 during the waking hours and 1:8 during the sleeping hours.

The review of the Annual Staffing Plan Assessment determines whether adjustments are needed in accordance with the standard. The staffing plan details the methodology that ensures adherence to the staffing ratios.

Unannounced rounds of the facility for the maintenance of a safe environment are conducted and documented by members of the management team. Policy and practice provide staff members are prohibited from alerting other staff regarding unannounced rounds occurring. The interview with the Training Coordinator/PREA Compliance Manager confirmed the practice.

JUST/TOA II meets the requirements of this standard based upon the following evidence:

The facility's PREA Policy prohibits cross-gender pat-down searches and prohibits staff from conducting cross-gender strip or cross-gender visual body cavity searches of residents. All residents can shower, perform bodily functions, and change clothes without being observed by staff of the opposite gender. Interviews with staff and residents confirmed this practice.

The PREA Policy supports that staff shall not search or physically examine a transgender or intersex resident to determine the resident's genital status. Signs are posted stating that female staff should announce themselves when entering the dormitories and the PREA Policy directs that staff of the opposite gender shall announce themselves when entering an area where residents may be showering, performing bodily functions or changing clothes.
